

## BEACON HILL COMMUNITY POOL RULES

- 1.) THE POOL IS FOR THE EXCLUSIVE USE OF BEACON HILL RESIDENTS AND ADMITTANCE IS REGULATED BY THE FOB SYSTEM.
- 2.) RESIDENTS MUST ACCOMPANY AND ARE RESPONSIBLE FOR ALL GUESTS.  
RESIDENTS WITH GUESTS ARE REQUIRED TO SIGN-IN THEMSELVES AND THEIR GUESTS.
- 3.) CHILDREN, UNDER THE AGE OF 14, ARE NOT PERMITTED IN THE POOL OR POOL AREA UNLESS ACCOMPANIED BY A PARENT OR RESPONSIBLE ADULT.
- 4.) NO RUNNING OR ROUGH PLAY IN OR AROUND THE POOL.
- 5.) BE MINDFUL OF OTHERS WHEN USING POOL TOYS OR RAFTS.  
WATER GUNS AND SOAKERS ARE PROHIBITED.
- 6.) DISRUPTIVE PERSONS WILL BE DENIED ACCESS TO THE POOL.
- 7.) ALL INJURIES, HOWEVER SLIGHT, MUST BE REPORTED TO PROPERTY MANAGEMENT.  
PHONE NUMBERS ARE POSTED IN THE PUMP ROOM.  
IF IT IS AN EMERGENCY, CALL 911.
- 8.) IF YOU HAVE ANY INFECTIOUS ISSUES, STAY HOME.
- 9.) NO GLASS PERMITTED IN THE POOL AREA
- 10.) TRASH MUST BE DEPOSITED IN APPROPRIATE RECEPTACLE.
- 11.) THIS IS A FAMILY RECREATION AREA; DRESS AND ACT ACCORDINGLY
- 12.) KEEP POOL STEPS AND LADDERS CLEAR
- 13.) NON-SWIMMERS ARE PROHIBITED IN THE DEEP END.
- 14.) SWIM AT YOUR OWN RISK; THERE IS NO LIFEGUARD ON DUTY.
- 15.) GRILL USE IS LIMITED TO POOL HOURS AND THEY ARE TO BE CLEANED AND COVERED AFTER USE.  
NO OTHER GRILLS ARE PERMITTED.
- 16.) NO PARKING IN BUILDING #11'S LOT
